#### II. Reason for proposed action

Students who earn an MSED in Counselor Education generally have two distinct career paths. The majority of the graduates take practitioner positions in schools, community mental health settings, or private practices. Some will continue graduate work and earn a doctoral degree in Counselor Education or related human services discipline. Alumni, employers, and community advisors have consistently indicated that if those who take positions as master's level practitioners substituted additional practitioner oriented course work for a research paper, they would be better prepared for their respective jobs. Students will continue to have the opportunity to complete a formal thesis as preparation for further graduate work.

# <u>Delete</u>: Core requirements consist of competencies in learning, quantitative methods, and development. Specific course selections to meet the degree program are determined by the students and their advisers with approval of the department chair.

Completion of a thesis, research paper or project (1-6 hours) is required to meet the requirements of a master's degree in education. A thesis requires a research format using a formal method of inquiry to answer basic questions in the filed. Research papers or projects focus on specific information-gathering
